## TOURNAMENT RULES

- 1.This tourney is a non sanctioned handicap mixed tournament. Tournament director has the right to refuse any bowlers or entry. Tournament director has the right to adjust any bowlers average.
- 2.No touring pro bowlers will be allowed to bowl. Violation of this rule will disqualify the individual and the team members as well. No Money will be refunded .
- 3.Team maximum average is 1000. Team must consist of 5 bowlers, with at least 1 of the opposite sex.
- 4.Total scratch and handicap series will determine where a team places.
- 5.Bowlers will use one of the following averages in this order: Current ITA average based on 36 games as of Sept. 1<sup>st</sup>, 2015 72 game ITA average. Bowlers not having an ITA average will use their highest 2014-15 USBC book average. Current average of 21 games or more as of 9/25/15 All others will bowl scratch. (210)
- 6.Handicap will be 80% of 210 for both men and women. **Bowlers without a current ITA average shall have a maximum handicap of 40 for men and 60 for women per game for side pots. Team handicap 80% of 1000.**
- 7.Team captains are responsible for team check in. Any corrections or changes to team roster, averages, or handicap must be reported before the start of the first game. Any bowler arriving after the start of the tournament competition will receive zero for all frames missed.
- 8.If a bowler abuses any of the bowling center equipment, the bowler will be immediately disqualified from the tourney and forfeits any claims for prize fund, side pots, brackets, etc.
- 9.Any protest affecting the eligibility, scores bowled, or general playing rules, must be specified in itself, and must be filed in writing with the tournament director prior to pay off.
- 10.ALL TOURNAMENT DIRECTORS DECISIONS ARE FINAL**
- 11.No refunds will be made after entry has been received.
- 12.Tournament bowlers will not be allowed on the tournament lanes after they have been oiled.
- 13.In addition to the above rules, USBC tournament rules will govern the operations of the tournament.
- 14.Capital City Bowlers and Mel's Lone Star Lanes will not be responsible for accidents occurring before, during, and / or after any event of the tournament.
- 15.Remittance must accompany each entry. Club checks, cashier checks or money orders only. **CASH** only on the day of the tournament.
- 16.Make checks payable to Mel's Lone Star Lanes.
